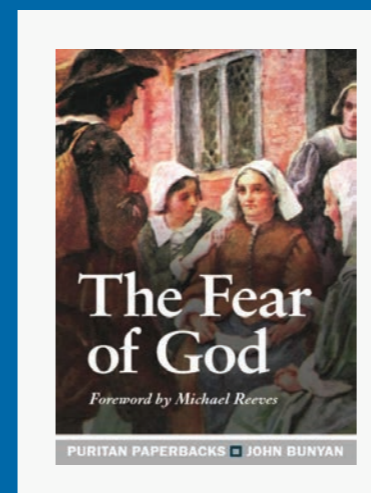

## Book of the Week: The Fear of God, by John Bunyan

Published the year after his Pilgrim’s Progress, in 1679, Bunyan’s Treatise on the Fear of God takes a widely misunderstood and neglected theme, wipes off the grime of confusion, and lets it sparkle. And sparkle really is the word: where most assume that the fear of God must be the gloomy theological equivalent of eating up your greens, Bunyan shows what a delightful and helpful subject it is.

## This happened after I offended a Hindu

One of our elderly neighbors had brought over some lemons. She often did that. I'd witnessed to her very likeable Hindu husband, and he was very open. So, I decided to witness to his wife as we paused for a moment and talked in our driveway. I said, "Hajit, do you think there's an afterlife? What happens when people die?" Suddenly, she looked fearful and began to walk away backwards. It was a disaster, and it broke my heart. I felt as though I had offended a gentle and very sweet elderly woman.

Still, they took my books when I gave them fresh eggs. It was a little discouraging though, because one time I noticed that the books were on the same shelf in their home right where they had put them months before.

One day as I rode my bike, I greeted her and saw the same fear in her eyes. But then I saw something strange. In that one glance, it was as though she was saying, "Please...help me!" The Bible says that every human being is haunted by the fear of death "all their lifetime" (see Hebrews 2:14-15). I was convinced that that day she was crying for help in the face of the impending Grim Reaper, something the Scriptures call "the king of terrors."

So, I immediately wrote a booklet with her in mind, called, "How to be Free from the Fear of Death." It expounded a simple but extremely profound principle. Here it is:

*If you were standing on the edge of a plane, 10,000 feet up, and you had to jump without a parachute, would that be fearful? Of course it would. It would be breathtakingly terrifying. But if I gave you a parachute that you knew for certain would open, would that change things? Of course it would. Radically! Now, instead of hitting the ground at 120 mph on your face, you are going to land at 15 mph on your feet, and because of this you are no longer fearful, because you trust the parachute. The amount of fear you have will be determined by the amount of faith you have in the parachute. If you have 100% faith, that would mean that you have no fear. Your faith actually controls your fear.*

*And so our faith in the Savior dissipates our fear. We can control it. The King of Terrors has been dethroned. I came into this world with nothing, but I will leave with my hand in the hand of Jesus.*

I couldn't wait for the booklet to be printed, and the moment they arrived I grabbed a couple of copies along with some fresh eggs, and left them on their doorstep. That same day Hajit came across to our house and didn't just stand on the doorstep this time. She wanted to come in. She had some gifts, and joyfully told me that she had read the booklet! I'm not exaggerating when I say that when she spoke, she had a sparkle in her eyes.

You may have seen a short video that went viral of a bus driver wiping sweat from his brow, as he spoke of people getting onto his bus and coughing openly. He was angry because of their carelessness. Two days later that dear bus driver was tragically dead of coronavirus.

I'm sure that video added to our fears. People are justifiably scared. And perhaps for the first time in their busy lives, millions are seriously thinking about their own death.

*I believe that this booklet is written for such a time as this.* Even before this pandemic, it began to go off our shelves like no other publication we've ever produced.

At the same time, those of us who care about the lost have a dilemma. How do we get people to take a booklet when we can't even approach them? You do what I did. You leave it on your neighbor's doorstep.

One of the most delightful videos I have ever seen was recently sent to me by a friend. It was only about 30 seconds long, and it showed him and his wonderful family running through a Southern California neighborhood at 7 am, leaving coronavirus tracts on doorsteps. They gave out 200 that morning. It was so encouraging to see.

However, we discontinued the tract that they were giving out. This is because we believe “How to be Free from the Fear of Death” is so much better, because it addresses the felt-need of literally millions. It scratches exactly where they itch.

And one significant benefit of it being a booklet (as opposed to a single lightweight tract, such as the Million Dollar Bill tract) is that it is 20 pages and has weight. That means it won't be blown away by the wind if you leave it on a doorstep or tuck it into a screen door.

May you prayerfully consider getting this booklet and leaving it on doorsteps in your neighborhood. The fields are truly ripe.

## Telemedicine Abortion Gets Green Light From Federal Court

Judge frees abortion pill from doctor visits (for now). A federal court ruled Monday that women seeking abortion pills during the COVID-19 pandemic should not have to visit a doctor in order to obtain them.

Under current rules set by the U.S. Food and Drug Administration (FDA), non-surgical abortion— i.e., the kind that's induced by pharmaceuticals, not physicians—still requires patients to visit a hospital, doctor's office, or medical clinic to be prescribed the abortion drugs, even though a patient will go through the process at home.

“A medical or medication abortion uses two drugs to terminate a pregnancy,” explains a new report, “Prescription Denied: Accessing the Abortion Pill,” from Newsy. The first of these pills, mifepristone, “blocks a hormone to induce the abortion. The second drug, misoprostol, completes it by expelling the pregnancy. But mifepristone, which for medication abortion goes by the brand name Mifeprex, is among the most restricted drugs in the U.S. which makes it challenging to get. ... the Food and Drug Administration imposes tighter restrictions on Mifeprex than on opioids such as fentanyl.”

The American College of Obstetricians and Gynecologists (ACOG), the National Women's Health Network (NWHN), and other groups have been pushing the FDA to revise its rules so that abortion patients can see doctors via telemedical appointments and then receive their pills in the mail.

"If the laws and regulations that determine the terms of abortion access in the United States were based on science—not politics—medication abortion would be widely available in the United States without medically unnecessary restrictions on distribution," states an open letter signed by a range of physicians and health and advocacy groups.

On Monday, U.S. District Judge Theodore Chuang seemed to be in agreement with these advocates and doctors, writing in his decision that "in-person requirements" for abortion pills present a "substantial obstacle" to patients and are likely unconstitutional.

The judge issued a preliminary injunction blocking enforcement of the FDA's rules on mifepristone for abortions until at least 30 days after the U.S. Department of Health and Human Services declares an end to our current public health emergency.

"We look forward to a day when federal reproductive health care policy is grounded in science, not animus, and this medically baseless requirement is lifted once and for all," said Julia Kaye, a staff attorney with the American Civil Liberties Union's (ACLU) Reproductive Freedom Project, in a statement.

The lawsuit challenging the FDA's rules on abortion drugs was filed by the ACLU on behalf of the AGOC and other groups. ("In addition to the case decided today, the ACLU has another case challenging a broader range of FDA restrictions on medication abortion care that was filed prior to the COVID-19 pandemic," the organization noted in a press release yesterday. "More information on that challenge can be found here.")

The Monday ruling "represents a victory for patients, who should not have to face the additional burden of increased COVID-19 exposure as a condition of receiving their prescribed mifepristone," said ACOG President Eva Chalas in a statement. "It also represents a victory for the dedicated clinicians who are working to provide needed care without unnecessary exposure of patients, their families and the members of the healthcare team, to the novel coronavirus."

"The states of Indiana, Louisiana, Alabama, Arkansas, Idaho, Kentucky, Mississippi, Missouri, Nebraska and Oklahoma had asked to intervene in the lawsuit," arguing "that the case could impact how they enforce their own state laws that relate to or reference the FDA's regulation of mifepristone," notes the Associated Press. But "Chuang rejected their request last month. The judge said the federal case would not eliminate any state's ability to continue to regulate abortion medication 'above and beyond' the FDA's requirements."

In other abortion-related rulings released yesterday, a federal court has declared Georgia's "heartbeat law" unconstitutional. The law, passed last year, banned abortion at the point that any fetal cardiac activity could be detected, which occurs just a few weeks into pregnancy.

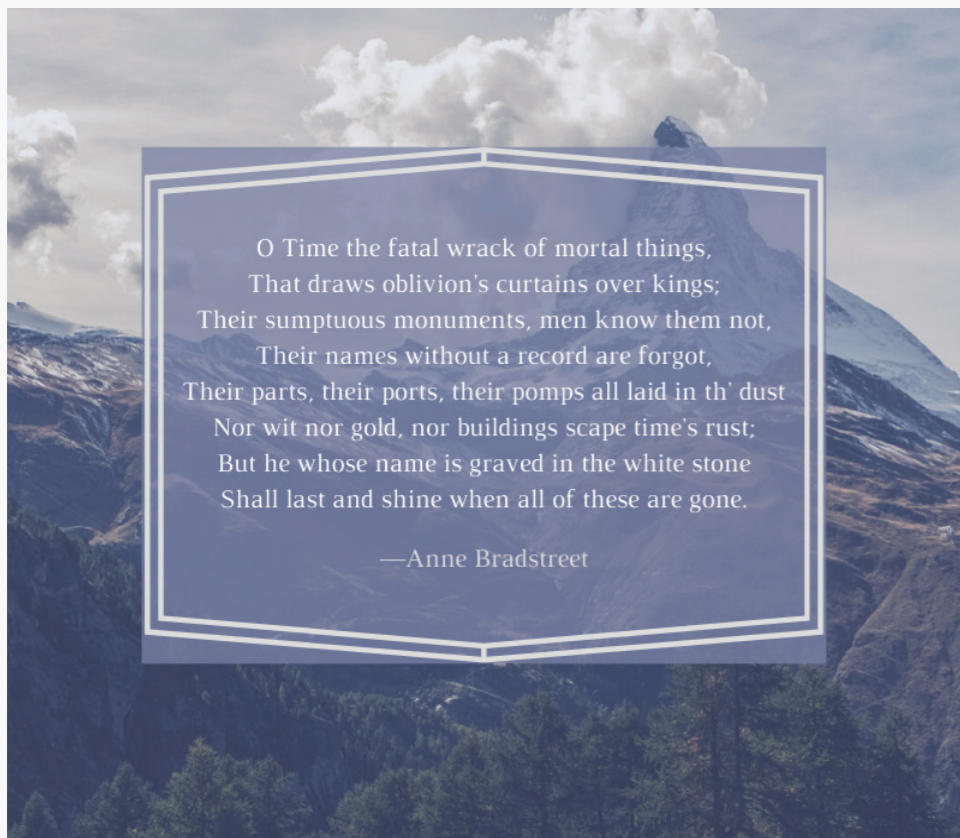

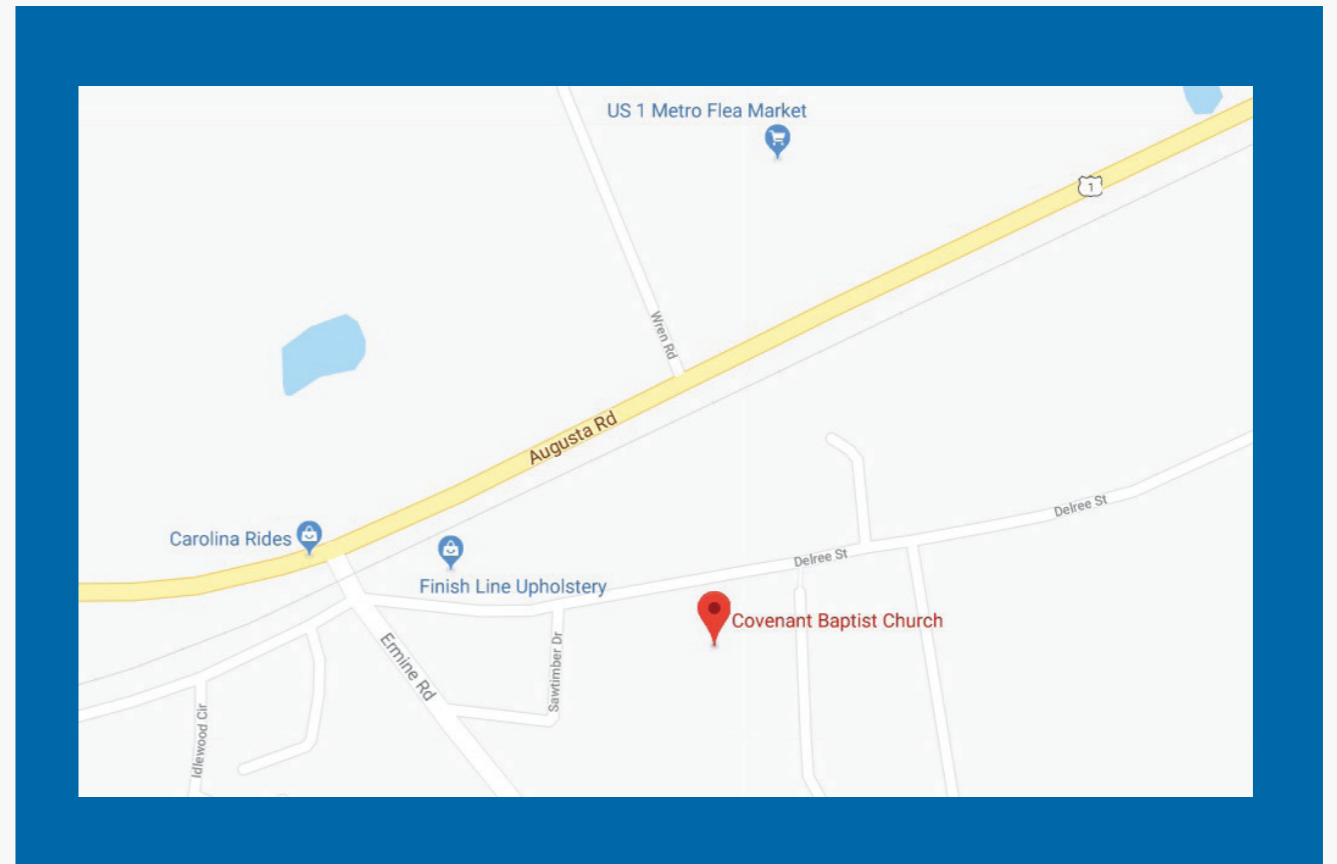
